- PRIMARY ROUTE:**  
Approx. Distance 80 miles
- Travel north on I-15  
from Blue Diamond Rd to exit 42A  
US95 NB Reno  
Merge onto US95 NB  
Continue on US95 NB to SR160  
Mile Marker 13 NY
- SECONDARY ROUTE:**  
Approx. Distance 90 miles
- Head east on NV-160 E/Blue Diamond Rd  
Turn left onto S Durango Dr  
Head north on S Durango Dr  
Turn right onto Roy Horn Wy  
Use the left 2 lanes to merge onto  
Clark County 215 E via  
the ramp to Henderson  
Head east on Clark County 215 E  
Take exit 12B to merge onto I-15 N  
Head north on I-15 N  
Use the right 2 lanes to take exit 42A  
to merge onto US-95 N  
Continue on US-95 N

Approx. Distance 16 miles
